Your conclusion should be brief and concise, with four well-written sentences. You should not add new information or introduce concepts that aren't discussed in the body paragraphs.

The conclusion should tie up loose ends and strengthen your argument. It will also remind the reader of the importance of your topic.

A powerful way to grab the attention of the reader is to include quotations at the end of your essay. It is important to use them with caution. The reader could mistakenly interpret the statement as if it was an expert's opinion.
